INTRODUCTION

Diaconia Center of Relief and Development was founded 6 years ago. It was established in 2011 due to the desire of the Diaconia to react to poverty beyond the Czech Republic as well.

We took over from many before us: congregations from the Evangelical Church of Czech Brethren, who supported the work of other organizations; Diaconia, who organized an Easter collection to support work in Ethiopia; numbers of volunteers, who long before our foundation helped their fellow citizens hit by floods.

Our center has taken over this seed and helped it grow. Nowadays we cooperate with partners from different countries. With some it has been for years, with others we are happy to start working now. We focus on agricultural, social and educational projects. We work with volunteers in the Czech Republic and abroad. We are there with the people hit by humanitarian disasters.

And there are more challenges ahead: most of all, we want to get closer to the people who need our help. We have therefore started setting up representation centers abroad, directly in the countries where we work.

All this is not only our work, the work has been mainly done by you. We work with your support and in your name. We appreciate that. None of this would be possible without you. To all of us, I wish joy out of what we can do together.

Enate, Ethiopia

Enate and her son live in a small sheet metal house. Her husband died of AIDS. Enate fell ill as well and has only been able to walk with crutches. When her husband died, she found out that she was HIV positive too. Her life changed when she found out about the programme Diaconia for Women. She did the training and learnt completely new things. She got some money to set up a business and started selling vegetables.

Enate is also a member of a group for HIV positive women. The women built showers out of their earnings, which are run by Enate. The showers located in a busy part of town are used by about fifty people a day. Most of the money people pay for using the showers goes back to the group's savings. This way, Enate earns 350 birr a month so she can buy medicine for herself, look after herself and her son, pay for her son's school and even save some money.

Alad, Jordan

Alad, 21 years old, is single and has been in Zaatari camp since 2012. She studied at a secondary school in Syria and dreamt about becoming a lawyer. Then the war came. One day, Alad drove with her mother and brothers to the Jordanian border and then they continued on foot until a police patrol took them to the camp. They feel safe there but they have too much free time. Alad says: "Some days I make myself believe that I am in a hurry and have to run lots of errands. I quickly get dressed and eat my breakfast in a hurry. Then I go out and walk somewhere fast. It doesn't matter where because I actually don't have anything to do."

There is very little work at the camp. The people have enough to eat and a place to sleep. But a person needs more, of course. Alad has stopped dreaming about becoming a lawyer. She does not know what will come next or how long she will have to stay at the camp for. For the time being, she has signed up for a computer skill course in a youth centre called Peace Oasis. Thanks to the course, she can study something at the camp. And at the same time she has greater hope that one day when the war ends, she will find a job.

Ne, Cambodia

Mr. Ne Samol lives with his wife and 3 children in the village Austouk near the provincial town Battambang. He grows rice on his 8 hectare field. During the training, he learnt about SRI technology (System of Rice Intensification) and was given certified seed stock. Even though he now has extra work with pre-growing young rice plants, which he then has to replant into the field after 10 days, he saves money on seed stock and his profit is larger. Ne passes on the know-how as he knows the method works. Mr. Ne also breeds frogs and fish. He keeps the frogs in his garden behind his house and the fish in a nearby pond. He got his initial training and money for the breeding from the project. There were complications when a large proportion of the frogs died due to water contamination but he still has enough to sell. Mr. Ne has been successful enough to also start selling his own certified rice seed stock, which he produced on his field. His family is much better off now than before.



Emily, Zambia

Emily looks after 6 children of her own and 4 orphans. She and her husband are farmers, but they did not have enough money for fertilisers and their income from their production was too small to feed all the children.

The bank can give them a loan, but the debt then has to be paid the following month with 2% interest. They have a small savings fund but their savings are not enough for more business. Emily at least manages to buy flour from the little money they save and uses it to make so-called fritters and scones which she then sells at the local market.

Emily is a member of a local self-help group. The women created a fund with 6 000 kwacha, from which they can borrow money to start a business. Emily used the fund as well and bought tomatoes, lettuce, potatoes and fertilizer for 1000 kwacha (100 USD). She grows vegetables of higher quality and runs her own business. She has managed to put 1020 kwacha back in the fund and she still had money left to buy more young plants. Emily is happy to be independent and to be able to feed her family.



Florence from Zambia joined our program to support small businesses. As a result, she can now take her son to a hospital which is 20 km away. She would not be able to walk such a distance with the child in her arms. However, she can easily cycle the distance even with the boy. She bought the bike from the money she earned selling vegetables and sweetcorn, which she grows thanks to a loan from a self-help women's group. "My vegetable garden has been thriving. We will be able to pay the school fees for our four children from the money from the business. I hope that thanks to your help, all our children will be able to finish school, which we couldn't," says Florence.

To support Zambian women, you can buy a bag of cement for 175 CZK. Don't worry, we will not send the bag to your home. We will buy it in Zambia, where it will help to build wells or dams for small farmers such as Florence. You can give the certificate as a gift and inspire other donors this way.



An Independent Auditor Report for the organisation Diaconia ECCB – Center of Relief and Development

Auditor's Finding: Without Reservations

We conducted an audit of Diaconia ECCB – Center of Relief and Development (“Organization”) The Balance Sheet Report drawn up is based on Czech accounting regulations. The Balance Sheet Report consists of a balance sheet as of December 31st, 2016, a profit and loss report for the accounting year finishing on December 31st, 2016, and an appendix to the Balance Sheet Report containing a description of the accounting methods used and further explanatory information.

In our opinion, the Balance Sheet Report shows the true state of the Organization's assets and liabilities as of December 31st, 2016; of the costs and expenses; and of the result of the Organization's management in the accounting year finishing on December 31st, 2016; in accordance with Czech Accounting Regulations.

Basis for the Finding

We conducted the audit in accordance with the Act on Auditors and the audit standards of The Chamber of Auditors of the Czech Republic. The standards correspond with International

Standards of Audit (ISA), at times supplemented and amended with application clauses. Our accountability determined by these regulations is described in more detail in the section Auditors Accountability in the Balance Sheet Report Audit. In accordance with the Act on Auditors and with the Ethical Codex adopted by the Chamber of Auditors of the Czech Republic, we are independent of the Organization, and we have also fulfilled further ethical requirements resulting from the regulations mentioned above. We believe that the evidence we collected provided us with sufficient and suitable basis for our finding.

***Diaconia Resources** (fourth column) are funds which Diaconia ECCB – CRD secured from institutions, companies, individual donors in the Czech Republic or from foreign partners. The budget of the project and the funds of the Diaconia are different, where Diaconia ECCB – CRD cooperated on a project also financed by other donors.

The development projects in Cambodia, Moldova, Zambia and the GDE project were financed from the Czech Development Agency and the Czech Ministry of Foreign Affairs funds within the scope of foreign development cooperation of the Czech Republic. The humanitarian projects in Jordan, Myanmar and Syria were financed from the funds of Czech Ministry of Foreign Affairs.

HOW WE WORK

In every country we work in, **we cooperate with local people**. Only in this way are we sure that our help gets to the people who need it the most. We help the non-profit organizations on site gain funds and we provide them with support and Czech expertise.

With the help of our **international partners** we get more finances and thus we can broaden our work.

We are **Act Alliance** members, which is an association of 144 church based humanitarian organizations and we often cooperate on joint projects with their members all over the world.

How does it look? For example, German Diaconia Katastrophenhilfe financially secures the Resilient Village program, in which we work with Czech villages to prepare for future floods. Diaconia Katastrophenhilfe also helped, for example, in Haiti after hurricane Matthew. We added to their help with a collection, which took place in evangelical church congregations. We cooperate in a similar way with the Lutheran World Federation in Jordan and Myanmar.




The results of our work are important to us and we keep learning. We go to places where we help and talk directly with the people who accept our help. We also make use of expert external assessment.

WHERE WE HELP




Two thirds of our aid was sent **abroad** in 2016. We helped people who had to leave their homes because of the **war in Syria**.

The money collected in the Czech Lenten Collection was used for other centers' activities in refugee camps in **Northern Iraq**, where women and girls try to come to terms with the traumas of war.

With the support of the Czech Ministry of Foreign Affairs, we helped in **Jordan, Syria and Myanmar**.

Besides humanitarian aid, we also organize **development projects** in Africa and Asia. We want to support people who are the least able to be self-reliant and feed their families. For instance, in **Cambodia** we teach small farmers how to grow rice more effectively and how to fertilize correctly. In **Zambia**, we encourage women to set up small businesses in order to save the earned money separately or together in a self-help group and ensured a more dignified life for themselves and their family, as well as education for their children.


Prevention, Awareness Raising and Education in Humanitarian Area
